**Description:** Antibodies are purified at ABL from the tissue culture supernatant from mouse cell lines or mouse ascites fluid using Protein A chromatography. MoAbs are formulated in Phosphate Buffered Saline (PBS). Material is sterile filtered with 0.2 micron filter. Quantity per vial: 100 µg in 50 to 200 µl
