# **Privacy Policy Statement**

Advanced BioScience Laboratories, Inc. ("ABL") and its affiliates ("We", "Us" or "Our") are committed to protecting the privacy and personal data of Users of the www.ablinc.com website (the "Site"), meaning any information about You which is personally identifiable (such as Your name, address, telephone number or email address) that we may collect from You or which You may submit to or through the Site.

In accordance with laws governing the protection of personal data, You are hereby informed that while connecting to this Site, Your personal information may be automatically or voluntarily collected, retained and utilized by Us as described herein.

This privacy policy statement (the "Privacy Policy Statement"), our Terms & Conditions of Use and Our Cookie Policy together describe how We may use Your personal data and how that information may be used or disclosed by Us.
